

# **P3 Protégé - Assistant Teacher Contract**

## **Contract Agreement**

This contract ("Contract") is made and entered into as of July 12th, 2025 by and between \_\_\_\_\_ ("Dancer") and P3: The Convention ("P3").

## **Terms of Agreement:**

### **1. Requirements of Role:**

- Dancer agrees to attend our KC convention + 1 more convention as a P3 Protégé - Assistant Teacher.
- Dancer agrees to follow and share P3 posts on Instagram, Facebook, and Tik Tok.
- Dancer agrees to maintain positive and friendly social media accounts.
- Dancer agrees to behave professionally and respectfully at all P3 events.
- Dancer agrees to assist instructors during classes, manage backstage activities, provide guidance to participants, and ensure the smooth flow of events.

### **2. Audition Process:**

- Date and Location: Auditions will be held at the Lied Center of Kansas P3 Nationals event on Saturday, July 12th, 2025.
- Audition Fees: A \$50 fee per dancer will be collected when signing up.
- Audience: All auditions are closed.

### **3. Additional Terms:**

- Dancer must provide a resume and headshot.
- Dancer agrees to represent P3 with respect and integrity, embodying the values of our organization at all times.
- Dancer must wear solid black dance apparel and jazz and tennis shoes during the audition process.

### **4. Disclaimer:**

P3 Talent Competition (hereinafter referred to as "the Organization") would like to emphasize that while every effort is made to ensure the safety and well-being of all participants, including dancers, during P3 events, the Organization cannot guarantee the safety of individual dancers at all times.

Participation in P3 events, including but not limited to dance performances, workshops, and competitions, involves inherent risks, including the risk of injury. Dancers are expected to exercise caution and adhere to safety guidelines and instructions provided by event organizers, instructors, and staff.

By participating in any P3 event, dancers acknowledge and accept the risks involved, and agree that the Organization, its affiliates, sponsors, and staff shall not be held liable for any injuries, damages, or losses sustained during the course of the event.

Dancers are responsible for their own safety and are encouraged to take appropriate precautions, including but not limited to warming up properly, using suitable footwear and attire, and respecting personal physical limits.

The Organization reserves the right to modify event schedules, rules, and safety protocols at any time for the well-being of all participants.

Participants are advised to obtain appropriate insurance coverage to protect against any unforeseen circumstances or injuries.

By attending or participating in any P3 event, dancers implicitly agree to abide by the terms of this disclaimer.
